<u>Bike Racks Report</u> – The CEO prepared a report for Board information regarding the purchase of specialized bike racks for the Library.

Seiberling-Spriggs that the Orillia Public Library Board approves the transfer of funds from the Building Fund Donations reserve account (56-6-3210-0844) to the Facilities Capital bike rack account for an amount not to exceed \$5,000 in support of purchasing bike racks to be installed in the covered area in the courtyard.

<u>OLA Conference Board Attendance</u> – The Board members were reminded about the upcoming conference and their possible attendance.

<u>Bill 132 Better for People, Smarter for Business</u> - The CEO reported that the Bill received first reading with two points relating to libraries where Canadian permanent residents can now serve on library boards as opposed to Canadian citizens, and the possible change from a minimum of 10 meetings per year to as little as 4 per year. FOPL is surveying libraries for their opinion as requested by the government. Too few meetings may mean harder integration and challenge operations.
